In response to some queries/suggestions received from the prospective bidder and for revision of several requirements of BSCCL, the following amendments of the tender document of the tender title " Supply and installation of equipment & goods for establishment of digital classrooms in different schools for the disadvantaged and disabled students under the program of BSCCL" are hereby made by BSCCL:



1. Clause no-3.13(ii) is hereby amended as follows:

ii. The minimum specific experience as Supplier in supply, installation and commissioning of similar Goods (40" or bigger LED/LCD TV) of at least 1 (One) contract successfully completed within the last 5 (Five) years, each with a value of at least Tk. 20,00,000.00(Twenty Lacs) Only. If the bidder supplied the 40" or bigger LED/LCD TV and related devices along with other equipment/goods under the same contract, then the contract price of the 40" or bigger LED/LCD TV and related devices shall not be less than the amount mentioned above.

2. Clause no-3.16(a) is hereby amended as follows:

- a. Documents to Establish Performance of the Equipment: The bidder shall submit certificates from at least 02 (Two) different institutional users, which will demonstrate that any model of the proposed brand of TV (40" or bigger) have been running in the user's institution/organization satisfactorily for a period of at least two years. The equipment might not be supplied by the bidder to the user and the user may be in this country or abroad. The Certificates shall be in English or in Bangla. If the original certificate is not in English or Bangla, then an official English translation have to be submitted with the certificate in original language (other than English or Bangla).

However, the above requirement may be waived/relaxed for state owned manufacturers/assemblers.



3. Clause no-4.2 is hereby amended as follows:
